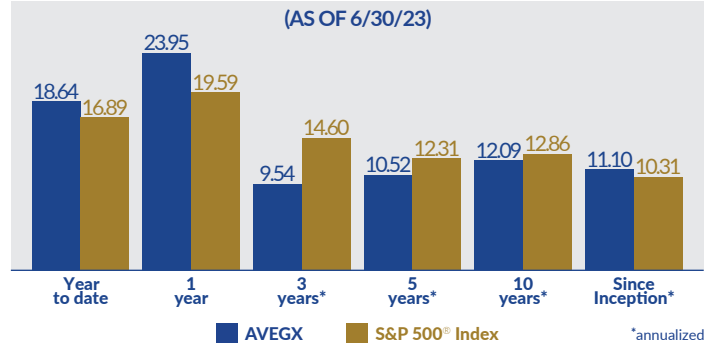

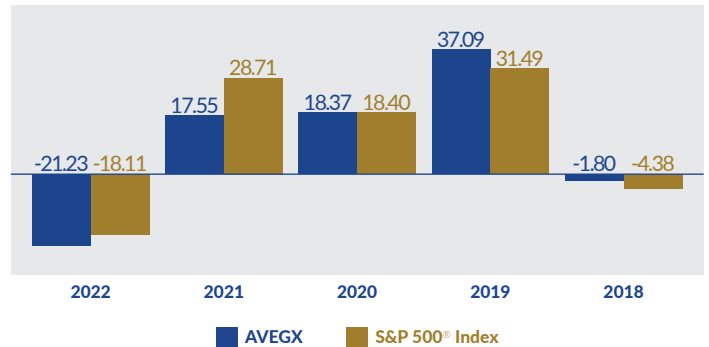

### AVERAGE ANNUAL TOTAL RETURNS (%)



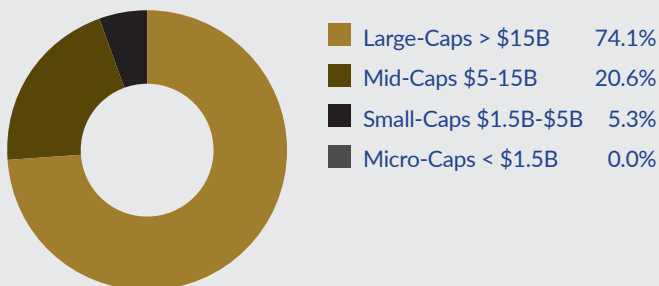
### LAST 5 CALENDAR YEAR RETURNS (%)



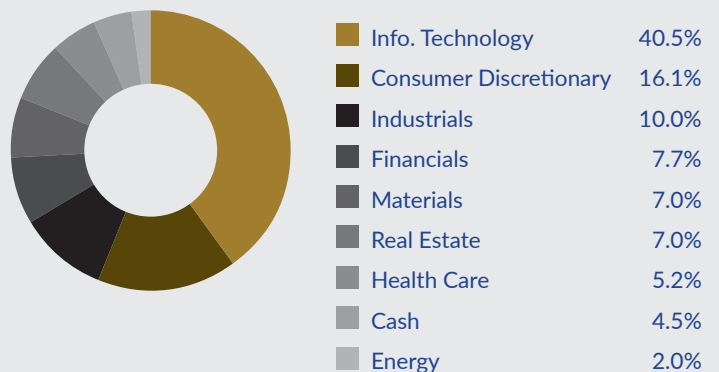
